	collection fees shall be paid prior to the shipment of semen. The mare owner will pay for all applicable shipping fees.				
3.	Shipping is via Fed Ex Standard overnight. For FedEx, there are no shipments on Saturdays or Sundays.				
4.		Semen orders must be placed with Blue Sky Veterinary Services 24 hours prior to shipment with a right to cancel by 12			
	noon the day prior to shipment. If the order is canceled under 12 hours noticed, the collection will be considered the one				
_	collection included with the collection fee, and the mare owner will be charged accordingly.				
5.	In the event of insufficient semen on a particular breeding day, Blue Sky Veterinary Services will ship on a first ordered, first served basis.				
6.	Owners should expect to receive one to two doses of fresh semen (depending on availability), or 2-8 straw breeding doses				
	of frozen semen. Any unused frozen semen remains the property of the Stallion owner and must be returned to Blue Sky				
	Veterinary Services at the mare owners' expense.				
7.	Stallion Owner has the right to refuse to breed any mare for any reason.				
8.	This breeding contract comes with a live foal guarantee to owner of the above-named mare. If the foal does not stand and				
	suck, or dies within 24 hours, mare owner will be entitled to a free breeding the following year to the same mare (unless				
	mutually agreed). This live foal guarantee only applies if the mare owner notifies the stallion owner within one (1) week from death; this notice must be accompanied by a statement from a licensed Veterinarian. Collection and shipping fees, as				
	well as any veterinary expenses will be the responsibility of the mare owner. If the mare proves not to be in foal in the year				
	bred, or loses her foal, as stated above, the stallion owner has the option to rebreed the same mare the following year. If				
	mare is not rebred the following year or the mare owner fails to deliver her for breeding the following year, then this				
	contract becomes null and void.				
9.	This contract provides for one Breeder's Certificate. Please notify Blue Sky Veterinary Services with the status (In foal/Open) of your mare at the end of the breeding season. Stallion breeding reports are prepared after the season.
